4. First aid measures

4.1. Description of first aid measures

After inhalation

Remove to fresh air, keep patient warm and at rest. Irregular breathing/no breathing: artificial respiration. If necessary, give oxygen. Summon a doctor immediately. If the patient is likely to become unconscious, place and transport in stable sideways position. Ensure supply of fresh air.

After skin contact

Wash skin thoroughly with water (15 min.). Remove contaminated clothing. Wash skin thoroughly with water (15 min.). Summon a doctor immediately. Remove contaminated, soaked clothing immediately and dispose of safely.

After eye contact

Remove contact lenses, irrigate copiously with clean, fresh water, holding the eyelids apart for at least 10 minutes and seek immediate medical advice.

After ingestion

Rinse mouth thoroughly with water. Take affected person to fresh air. Drink water in small gulps. Do NOT induce vomiting. Never give anything by mouth to an unconscious person. Summon a doctor immediately. Ensure supply of fresh air.
